LIMITED 2nd TO 5th YEAR COMPRESSOR WARRANTY

In addition to the above warranty, Heat Controller, Inc., warrants the COMPRESSOR ONLY for a total of five years.

WHAT IS NOT COVERED BY THE WARRANTY

- Normal maintenance
- Labor charges for diagnosis and repair
- Transportation charges for replacement parts
- Replacement of refrigerant or filters
- Any other service calls or repairs
