LIMITED (ONE YEAR) PARTS WARRANTY

All parts of the ductless mini-split system are warranted to be free from defects under normal use and service when installed per Heat Controller, Inc. installation instructions and in accordance with all local, state and national codes for typical installations.

LIMITED 2nd TO 5th YEAR COMPRESSOR WARRANTY

In addition to the above warranty, Heat Controller, Inc., warrants the COMPRESSOR ONLY for a total of five years.

WHAT IS NOT COVERED BY THE WARRANTY

- Normal maintenance
- Labor charges for diagnosis and repair
- Transportation charges for replacement parts
- Replacement of refrigerant or filters
- Any other service calls or repairs
