COMPRESSOR WARRANTY

Five Year Warranty: The compressor is warranted to be free from defects under normal use and service for five (5) years from the date of purchase by original owner in both single phase and three phase commercial installations.

PARTS WARRANTY

Parts are warranted to be free from defects under normal installation, use and service for one (1) year from date of purchase by original owner, when installed in commercial applications, excluding installations of systems that are not ARI-matched.

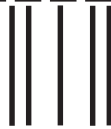
HEAT EXCHANGER WARRANTY

Warranties apply only when the unit is installed per Heat Controller, Inc., installation instructions and in accordance with all local, state, and national codes for normal use.

Transportation, handling, and labor costs to diagnose, repair or replace defective parts are not covered by this limited warranty and are the owner's responsibility. Ready access to the unit for service is the responsibility of the owner. Damages due to shipping, installation, handling or servicing are the owner's responsibility to resolve with the carrier, installer, dealer or distributor.

EXCEPTIONS: The warranty does not cover normal maintenance, labor charges, transportation charges for replacement parts, replacement of refrigerant or filters, any other service calls/repairs. The warranty does not apply if:

- Unit has been subject to accident, alteration, improper repair, neglect or misuse
- Performance has been impaired by use of any product not authorized by Heat Controller
- Serial numbers have been altered or removed
- Damage results from improper voltages, use during brown-out conditions, circuit interruptions or inadequate power supply
- Air flow has been restricted
- Components are damaged due to freezing, erosion, scaling or use of chemicals

DURATION OF WARRANTY/REGISTRATION CARD

The warranty begins on the date of purchase by the original consumer. The consumer must complete and return the warranty registration card or register on-line within 60 days and provide a receipted bill of sale as proof of warranty period. Without this proof, the warranty begins on date of shipment from the factory.

There are no other warranties, express or implied, which extend beyond the description in this document.
2. All warranties implied by law are limited in duration to the one year terms of the warranty. Your exclusive remedy is limited to the replacement of defective parts and compressor. **We will not be liable for any damages caused by any defect in this unit.** Some states do not allow limitation on how long an implied warranty lasts or do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusions may not apply to you.
3. No warranties are made for units sold outside the continental United States and Canada.
4. We will not be liable for delays caused by events beyond our control including accident, alteration, abuse, war, government restrictions, strikes, fire, flood, or other acts of God.
